- (i) Ref: S/2038/14/FL – **10 Boxworth End**, Mrs L Pope. Formation of new access and laying of driveway and parking/turning area for existing dwelling. For comment
- (ii) Ref: S/1775/14/RM – **18 Gibraltar Lane**. Mr M Miller. Amended plans to re-position dwelling on plot 3, decrease footprint of plot 2 and re-design the roof of plot 1.
- (iii) Ref: S/2011/14/OL – Development of **Phase 2 of Northstowe** with details of appearance, landscaping, layout, scale and access reserved (save for the matters submitted in respect of the Southern Access Road (West)) comprising:
 - 1) development of the main Phase 2 development area for up to 3,500 dwellings, two primary schools, secondary school, town centre including employment uses, formal and informal recreational space and landscaped areas, eastern sports hub, remainder of the western sports hub (to complete the provision delivered at Phase 1), busway, a primary road to link to the southern access, construction haul route, engineering and infrastructure works;
 - 2) construction of a highway link (Southern Access Road (West)) between the proposed new town of Northstowe and the B1050, improvements to the B1050, and associated landscaping and drainage
- (iv) Ref: S/2259/14/FL – Gallagher Estates. Revised scheme for construction of **pumping station** taking water from the upstream side of **Webbs Hole Sluice**, and discharging to the downstream/tidal water side of Webbs Hole Sluice
