## 2017/P04-4 PLANNING

4.1 The Chairman reported on attending the SCDC Committee on 5<sup>th</sup> April, to speak and represent the Parish Council's objections to the second planning application for up to 70 homes on land to the rear of 130 Middlewatch( \$\sigma \)(053/17/OL). District ClIr Mrs Ellington and a local resident also spoke on opposition of the application. The applicants were not in attendance. The Committee returned a decision to refuse the application (9 in favour of refusal, 3 against). The appeal for the first application is still ongoing with a decision expected around end April.

Chairman had also attended an SCDC Committee the previous week where the Cottenham application for 200 new homes by Gladman Developments had been discussed, with the decision made to approve the application, despite SCDC having refused an application for 225 on the same site during last year.
