1. Nomination papers may be obtained from the Parish Clerk or from the Returning Officer, South Cambridgeshire Hall, Cambourne Business Park, Cambourne, Cambridge, CB23 6EA who will at the request of any elector for any parish prepare the paper for signature.
2. Nomination papers must be delivered to the Returning Officer, South Cambridgeshire Hall, Cambourne Business Park, Cambourne, Cambridge, CB23 6EA between the hours of 9.00am and 5.00pm on any working day on or after the date of this notice, but by no later than 4pm on Friday, 6 April 2018.
3. If any election is contested the poll will take place on Thursday, 3 May 2018.
4. Electors and their proxies should note the following provisions in respect of absent voting applications:
  - Applications for new postal votes and amendments or cancellations of existing postal or proxy votes must reach the Electoral Registration Officer at South Cambridgeshire Hall, Cambourne Business Park, Cambourne, Cambridge, CB23 6EA by 5pm on Wednesday, 18 April 2018.
  - Applications for new proxy votes must be received by the Electoral Registration Officer at South Cambridgeshire Hall, Cambourne Business Park, Cambourne, Cambridge, CB23 6EA by 5pm on Wednesday, 25 April 2018.
  - Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at South Cambridgeshire Hall, Cambourne Business Park, Cambourne, Cambridge, CB23 6EA by 5pm on Thursday, 3 May 2018. The physical incapacity must have occurred after 5pm on Wednesday, 25 April 2018. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 25 April 2018
